What the SharePoint health check includes:





Loading times

As part of the performance testing, the load times are analysed to ensure there are no load issues, including inspecting custom pages, focusing on critical components, such as homepages and analysing load time in different web browsers.



Bespoke SharePoint design

Out of the box SharePoint has relatively basic branding and configuration. A review is undertaken for how a redesigned site can become a central hub for an organisation providing a branded enhanced look and feel.



User Experience Assessment

Navigating through the environment to review the journey from a user's perspective (both as an admin user and non-admin user) and from a useability point of view, review usage levels of different parts of the environment.



Site structure

Analysis of how individual sites are structured to complement the business functions and if they navigate effectively to a central location to provide a collective environment.



Permission Governance

A review of your permission and security set up to ensure the best practices are applied and that you have full control over who can access what in your various data stores.



External User Access

Analysis to determine if any data has been shared with external users and to ensure external sharing configuration and settings are not leaving the organisations vulnerable to a data breach.



Environment storage space

A review of storage space of both sites and content, to allow for planning of future storage needs.



Administrative access

Investigation into who has administrative access and why, to ensure only users who actively need admin capability have them and that the system is secure.



Data retention

A review of data retention policies and configurations to ensure these are applied correctly and suitable for your organisation. Retention labels confirm that your data is protected from accidental deletion and removal and guarantee that GDPR is being followed correctly.
